Organizational and legal issues in forensic psychiatry

The intention is to submit the analysis of the activities of forensic-psychiatric expert institutions in terms of their structure, beds available, human resources, volume of expert workload, and the nature of expert decisions taken. Forensic-psychiatric assessments in criminal proceedings

The intention is to discuss the contemporary approaches to classification, diagnosis, and forensic-psychiatric assessment of personality disorders, potential dangerousness of schizophrenic patients in remission, the legally significant capacities of defendants with comorbid pathology, taking as an example the combination of organic mental disorders and alcohol dependence; organic personality disorder and epilepsy. We shall submit the multidimensional classification of the forensic-psychological expert concept of affective states in crimes of passion/provocation and analyze the problem of concurrence of principles in assessing the affective states in the course of forensic examinations and law enforcement, describing the algorithm for carrying out the assessment of defendants' emotional states. It is proposed to submit the modern neuro- and psychophysiological diagnostic instruments (diagnosing sexual preference disorders with the use of the high-speed eye-tracking technique; differentiating between schizophrenia, the schizotypal disorder, and personality disorders, based on studying the indices of the P300 component and the evoked theta-rhythm within the paradigm of the probabilistic presentation of significant auditory stimuli).
